I, the undersigned player, acknowledge, agree and understand that:

1. Voluntary and of my own free will, I elect to participate as a member of the softball team with the North Kansas City Parks & Recreation.
2. I understand that there are certain risks and hazard involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, equipment and other participants.
3. I understand that sliding into base is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I the undersigned player, agree their consideration for the right to play as a member of the team designated below and inconsideration for permission to play on the fields arranged by the team or league:

1. I voluntary elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by the other teams or by other players on my team and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
2. I release, discharged and agree not to sue North Kansas City Parks & Recreation, The City of North Kansas City, the team or other entity designated below, the employees, or any person entity connected with the team, league, field for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND AGREE TO ABIDE BY THEM.
