## Definitions:

A <u>Storage Warehouse</u> is a building in which merchandise is stored in quantities, <u>not for sale</u>, but kept for a reasonable period until wanted by the owner.

A Non-Revenue Generating Location has no storage or sales but does conduct business within NKC.
