RE: CARES Funding – Clay County and North Kansas City

Congress passed and the President signed the Coronavirus Aid, Relief and Economic Security (CARES) Act on March 27, 2020. The CARES Act provides for Federal Stimulus Funds to flow to the States by population and to Counties within the State also by population. Generally speaking, these funds are to be used for reimbursement of expenses related to dealing with the covid-19 pandemic since the crisis's beginning to the end of the year. The funds cannot be used to make up for loss of revenue due to the crisis.

County governments are responsible for the distribution of these funds. On May 1, 2020, the Clay County Commission approved, by a vote of 2-1 (Ridgeway and Owen in favor, Nolte opposed) Resolution 2020-139, attached, which lists disbursements to entities within Clay County based on population.

County staff recommended to the Clay County Commission a distribution according to proportion of county population. NKC would receive up to \$417,769.15 per the chart in the resolution.

Presiding Commissioner Nolte has yet to sign the resolution, and consequently Clay County has not yet received its allocation of CARES Act funding. Commissioner Nolte has indicated that he is concerned that if sub-recipients misspend any of the funds, the County would be responsible for repaying the funds to the federal government. Commissioner Nolte has indicated, however, that if Clay County municipalities will agree to the conditions in the attached City resolution, he will sign the County resolution and the County and its member cities will hopefully receive their share of the distribution soon.

City staff has no concerns about accepting the conditions in the resolution, and recommends approval.

RESOLUTION

APPROVE CARES ACT AGREEMENT AND DISBURSEMENT FORMULA COMMISSION

BE IT HEREBY RESOLVED BY THE COUNTY COMMISSION OF CLAY COUNTY, MISSOURI THAT, the Commission hereby (1) approves the Federal Funding Certification agreement to receive direct payment from the State of Missouri pursuant to Section 14.435 of SS SCS HCS HB 2014 from the allocation of funds to the State of Missouri from the Coronavirus Relief Fund as created in the CARES Act, and (2) adopts the following:

GUIDELINES

Payments from the Fund are subject to the Department of Treasury's interpretation of the limitations on the permissible use of Fund payments.

Each recipient of allocations from the Fund shall retain records sufficient to demonstrate that the amount of Fund allocation has been used in accordance with section 601(d) of the Social Security Act.

If a recipient has not used funds it has received to cover costs that were incurred by December 30, 2020, those funds must be returned to the Department of the Treasury.

IMPLEMENTATION

In order to implement the distribution of the Funds, this Commission:

- Approves a one time disbursement to Community Partners from Clay County as outlined in Appendix A.
- School partner funding is approved but shall not be disbursed until the Department of Elementary and Secondary Education provides application for allocation of their respective CARE funding.
- Requires Community Partners to adopt, sign and notarize the Community Partner Funding Certification in Appendix B.
- Directs the County Auditor to establish a new Fund and accounts necessary to receive the revenue and create expenditure lines for disbursement as set out in Appendix C.
- Directs the County Auditor to assign Expenditure Authority designations in accordance with the current adopted budget for respective county offices and departments.

ACCOUNTABILITY & TRANSPARENCY

- Directs each Community Partner, Clay County Office and Department receiving CARES Act Funds under this Resolution, to provide documentation of all uses of the funds to the Clay County Finance Department by the 15th of the month following expenditures.
- Requires that preference be given to vendors operating out of Clay County, Missouri.
- Funds disbursed to Community Partners must be allocated to entities within the borders of Clay County, Missouri.
- Directs the Public Services Department to establish a separate Transparency Portal to display expenditures made from CARES Act funding.
- Community Partners will be asked to voluntarily return all or part of unused CARES Act funding on October 1, 2020 for reallocation to other Community Partners by October 30, 2020.

Any Commissioner voting in the majority is authorized to sign any documents to facilitate this order.

RESOLUTION NO. 20-031

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE DOCUMENTS RELATED TO DISBURSEMENTS OF CORONAVIRUS RELIEF FUND ALLOCATIONS FROM CLAY COUNTY, MISSOURI.

WHEREAS, the City of North Kansas City, Missouri (the "City") is a body corporate, a third class city and political subdivision of the State of Missouri, duly created, organized and validly existing under and by virtue of the Constitution and laws of the State of Missouri, and is located in Clay County, Missouri; and

WHEREAS, Congress passed and the President signed the Coronavirus Aid, Relief and Economic Security (CARES) Act on March 27, 2020; and

WHEREAS, the CARES Act provides for Federal Stimulus Funds to flow to the States by population and to Counties within the State also by population; and

WHEREAS, on May 1, 2020, the Clay County Commission approved Resolution 2020-139 which proposes disbursements to entities within Clay County based on population; and

WHEREAS, entities within Clay County must agree to use the funds as authorized by the CARES Act; and

WHEREAS, the City Council of North Kansas City, Missouri, finds it in the best interest of the community to accept these funds for unanticipated expenses related to the Coronavirus response and recovery, and for uses that may subsequently be authorized by the Federal Government or State Government and, therefore, the City Council desires to authorize the Mayor to execute the Community Partner Funding Certification on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH KANSAS CITY, MISSOURI, AS FOLLOWS:

<u>Section 1</u>. The Mayor of the City of North Kansas City is hereby authorized to execute the Community Partner Funding Certification attached hereto as Exhibit A, all in accordance with the provisions of this Resolution, and to take such other actions as may be necessary to effectuate the intent of this Resolution.

<u>Section 2</u>. The authority granted pursuant to this Resolution is subject to the following provisions:

- a. The City will retain documentation of all uses of funds, including, but not limited to, invoices and receipts. Such documentation shall be provided to the State of Missouri upon request.
- b. The City acknowledges that funds may not be used for revenue replacement unless subsequently authorized by the Federal and State Government.
- c. The City acknowledges that funds may not be used for expenses for which the

City has received other emergency COVID-19 supplemental funding for the same expense.

d. Any funds improperly expended by the City as determined by the Federal or State Government shall be repaid to the County by the City.

<u>Section 3</u>. <u>Further Authority</u>. The City shall, and the mayor, city clerk, city officials and employees of the City are hereby authorized and directed to take such further action, and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.

<u>Section 4</u>. <u>Severability</u>. The sections, paragraphs, sentences, clauses and phrases of this Resolution shall be severable. In the event that any such section, paragraph, sentence, clause or phrase of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential to and inseparably connected with and dependent upon the void portion that it cannot be presumed that the City has enacted the valid portions without the void ones, or unless the court finds that the valid portions, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent.

<u>Section 5</u>. <u>Governing Law</u>. This Resolution shall be governed exclusively by and construed in accordance with the applicable laws of the State of Missouri.

<u>Section 6</u>. <u>Effective Date</u>. This Resolution shall be in full force and effect from and after its passage by the City Council and approval by the Mayor.
