RE: Review of Ward Redistricting Process

Over time, people move, new homes are constructed, and neighborhoods change. That's why every ten years North Kansas City is required to redraw its City Council districts based on the latest U.S. Census data in a process called redistricting. The redistricting process helps ensure North Kansas City residents receive fair and equitable representation in our local government by equalizing the number of residents in each district.

Redistricting Requirements


A basic principle of redistricting is that legislative districts should be "compact", "contiguous" and avoid the "legislative evil commonly known as the 'gerrymander'."

Above all, when municipalities redistrict, the **new boundaries must be as equal as possible in population**. The combined percentage of deviation of the most populous district and the percentage of deviation of the least populous district from the ideal district population may not exceed 10% and all other district populations must fall within that narrow range.


For North Kansas City, our **ideal legislative district population is 1,117** (4,467 population ÷ 4 Wards).

Historical Perspective

North Kansas City's Wards have changed over the years to comply with the equal population mandate outlined in the U.S. Constitution.



The Need to Redistrict

North Kansas City's Ward boundaries no longer meet the 10% deviation required by the U.S. Constitution, therefore, the Ward boundaries must be redistricted.

Redistricting Process


The redistricting process is a **dynamic and continuous process** where multiple maps are developed, discussed, and modified based on resident and City Council input. The new ward boundaries are adopted by ordinance after a public hearing. The new ward boundaries must be set prior to the opening of filing for the April 2022 election on December 7, 2021.


City Council Work Session on Tuesday, October 19

In advance of the Tuesday, October 19, City Council Work Session, four draft maps (Maps A-D) were created and published for City Council discussion and resident input. Residents provided feedback on these maps through an online survey and direct feedback provided to their City Councilmembers. Councilmember Graves (Maps E-F) and Smith (Map G) also submitted maps to be included in the Agenda packet for the Tuesday, October 19, City Council Work Session.


During the Tuesday, October 19, Work Session, the City Council modified Maps C, E & F based on resident feedback.





For purposes of redistricting boundaries, the location of one resident/council member serving two year term should not take precedence for a decision that will impact all residents of the City over the next 10 years.

Map C - I do not like that Swift to Howell, between 26th and 28th Avenues, would be part of Ward 3, but would go back to Ward 1 for one block north of 28th. Also, the portions west of Howell are divided from the rest of Ward 3 by Wheel Park/NKC Highschool. This does not seem like a best effort toward maintaining a compact or contiguous Ward 3.

Map F- I'm not a fan of the carveout of a Ward 4 entering the current Ward 3 from the north. This splits the avenues along seemly random boundaries. The avenues currently have all similar house types and the proposed Map E would split these up with one side of the street being on one ward and other side in a second ward. This was used as an argument for not splitting up portions of Ward 1 at the last City Council meeting.
